



**PLEDGE for MEMBERSHIP
or POTENTIAL MEMBERSHIP in

_____ I understand that Theta Upsilon Gamma (T.U.G.) is a member chapter of Tri-Ess, and as such is a local gathering of Tri-Ess members. I pledge to maintain my membership in Tri-Ess as long as I expect to be a member of T.U.G.

_____ I understand the need to protect the security and confidentiality of my fellow members, and that anyone who violates a member's security and confidentiality will result in the loss of their Theta Upsilon Gamma (T.U.G.) membership at the first offense.

_____ I understand that inappropriate sexual behavior will not be tolerated, and will result in permanent expulsion from T.U.G. at the first offense.

_____ I agree that I will not be in possession of drugs, weapons, or alcohol, at T.U.G. activities and I will not attend a T.U.G. activity if I am intoxicated or under the influence of other illegal substances. Violation of this agreement will result in the loss of my T.U.G. membership.

_____ I understand that as a family oriented support group children accompanied by a legal guardian may be present at T.U.G. activities. The presence of children will not bother me.

_____ I understand that T.U.G. is a family friendly support group and the consequences for speech, behavior or dress offensive to the group, guests, or family members in attendance at chapter activities, or while our group is participating out in mainstream public activities; will result in counseling, it could result in being asked to leave the current activity, and may result in the loss of my T.U.G. membership if offensive conduct is repetitious or done intentionally. Loss of membership privileges and expulsion from T.U.G. for violating this policy will be determined by a majority decision of the current T.U.G. board members.

_____ I agree to abide by the policies of businesses sympathetic to T.U.G. and our members.

_____ I pledge that if I ever decide to pursue an identity other than that of a "Heterosexual Crossdresser", I will convert my "Tri-Ess" membership to "Friend of Tri-Ess" status. (This statement does not apply to T.U.G. applicants who are currently, or who are pursuing membership with Tri-Ess as a "Friend of Tri-Ess").

_____ By initialing and signing this pledge I understand that I am in complete agreement with the above listed policies of Theta Upsilon Gamma, and that anyone who violates these policies may be, or will be expelled from T.U.G., possibly on the first offense depending on which policy has been violated.
